Dubuque Bank and Trust is the third business to complete the Petal Project green business certification program

Dubuque, IA (April 9, 2012) - Dubuque businesses are leading the sustainability movement in Eastern lowa through their participation in the Petal Project, a green business certification program. Dubugue Bank and Trust is proud to announce that it has completed all of the certification criteria, positioning Dubuque Bank and Trust as the third business in Dubuque to achieve all requirements and become fully "Petal Certified." Dubuque Bank and Trust was the first business to join the Petal Project program in 2009. The business has gone above and beyond, certifying all eight of the DB&T branches in Dubuque County.

A Green Ribbon Cutting will be held Monday, April 23rd at DB&T (1398 Central Avenue) to celebrate their certification. A reception will start at 8:00 am, with the green ribbon cutting ceremony taking place at 8:30. The Green Ribbon Cutting is an opportunity to showcase an organization's dedication to environmental sustainability through completion of the Petal Project. Kelsey McElroy-Anderson, Regional Economic Development & Sustainability Coordinator of East Central Intergovernmental Association, (ECIA) said, "We congratulate DB&T for their leadership in this initiative and look forward to celebrating their successes at the green ribbon cutting in partnership with the Dubuque Area Chamber of Commerce."

"Dubuque Bank & Trust recognized the need to become a more sustainable organization when we embarked on this journey back in 2009. Through our partnership with the City of Dubuque and ECIA, as well as the commitment of our employees, we were able to turn this vision into a reality. As we have worked toward completion of the many steps necessary to become Petal certified, we mandated duplexing on printed documents, removed all fax machines and we began using IPADs in internal meetings and these are just a few examples of green initiatives undertaken at the bank. As with a traditional ribbon cutting, a team of local business, non-profit, and public sector leaders has come forward to make up the "Green Team", serving as ambassadors to the green businesses in the Dubuque community. Members of the "Green Team" include: Mayor Roy D. Buol, Cori Burbach (City of Dubuque), Tom Woodward (Sustainable City Network), Beverly Wagner (DMASWA), Sue Chapman (Finley Hospital), Sue Hafkemeyer (Loras College), with Bret Tuley being inducted in honor of DB&T's accomplishments.

Following the ceremony, the public is welcome to attend a free Sustainable Dubuque trolley tour sponsored by DB&T and hosted by the City of Dubugue and the Petal Project. The tour will depart from the DB&T parking lot following the ceremony and will end at approximately noon. The tour will highlight several buildings, projects and neighborhoods that have integrated various aspects of sustainability such as redevelopment of historic warehouses into urban apartments, adding solar panels to an existing building, installing native plantings, or developing sustainable practices in the work place.

Speakers will be available at stops including the Historic Millwork District, Bee Branch Creek Restoration, Municipal Services Center solar panel project, Washington Neighborhood Revitalization strategy and community gardens, the Carnegie-Stout Public Library, Water & Resource Recovery Center, Dubuque Metropolitan Solid Waste Agency methane capture and several others. The Petal Project is a regional green business certification program designed to encourage organizations in the Dubuque area to adopt environmentally friendly business practices. The program provides businesses with a simple framework for saving money and resources while establishing a community-wide definition of a green business for consumers wishing to shop based on their values.

The Petal Project is divided into five categories: pollution prevention, water conservation, waste reduction, energy conservation, staff education. Within each category, a business must complete all of the mandatory and a specified number of optional criteria to earn that petal. Once a business has earned all five petals, it is "Petal Certified".
